Abstract: The St. Philip's Church records (1867-1994, bulk dates: 1957-1978) document the administrative, spiritual, and social service activities of the Harlem-based Episcopal church. The majority of the collection reflects the career of Pastor Moran Weston, who served as rector of St. Philip's Church from 1957 to 1982. Weston's board activity, sermons, writings, and professional endeavors are strongly represented, as are the church's housing properties and its Community Service Council.

Creator History

After attending segregated Sunday services at Trinity Church, a group of free African Americans in New York City established the Free African Church of St. Philip in 1809. This church became St. Philip's Episcopal Church in 1819. The church relocated several times, gradually moving further uptown until March 25, 1911 when the current church building, designed by the prominent African American architecture firm Tandy & Foster, was dedicated on West 134rd Street in the Harlem neighborhood in New York City. St. Philip's Church is a designated New York City Landmark and on the National Register of Historic Places.

From its beginning in the nineteenth century, the church took a strong stance in challenging injustices such as slavery, racial discrimination, inadequate city services, and quality of life issues. Leaders of the church committed the institution to serving the greater good of the community, especially Harlem. Over time, the church acquired property in the surrounding neighborhood that would become both physically and financially integral to carrying out the church's various ministries.

Since centering its congregation in Harlem over a century ago, the church and its leadership have ministered to both its congregants and the Harlem community by providing religious and social programs and services. St. Philip's has operated and managed housing (including senior housing), a credit union, a daycare, and a community center; and in 1951 established the St. Philip's Community Service Council, which later became the Community Service Council of Greater Harlem. These entities were incorporated separately and overseen by individual boards of directors.

Milton Moran Weston (1910-2002) was an activist, businessman, and Episcopal priest who served as rector of St. Philip's Church from 1957 to 1982. The son and grandson of Episcopal priests in Tarboro, North Carolina, Weston attended junior college and graduated from St. Augustine's College in Raleigh, North Carolina. He then migrated north to New York City, completing an undergraduate degree at Columbia University in 1930 and a Ph.D. in social history at Columbia in 1954. Weston also undertook theological study at the Union Theological Seminary, where he received a Bachelor's of Divinity in 1934 and later a Master's of Divinity.

Weston served as business manager for St. Philip's from 1948 to 1951, before accepting a position as executive secretary with the National Council of the Protestant Episcopal Church. However, Weston returned as the sixth rector of St. Philip's in 1957, succeeding Rev. Shelton Bishop Hale. During his rectorate at St. Philip's, Weston oversaw the development of affordable housing programs (including senior housing), a community center, a nursing home, and the expansion of the St. Philip's Community Service Council (now the Community Service Council of Greater Harlem). Weston retired in 1982. During his service as rector, Weston was a long time trustee at several organizations including: St. Augustine's College, Columbia University (where in 1969 he became the first African American trustee), the NAACP Legal Defense Fund, and the Phelps-Stokes Fund.

Scope and Content Note

The St. Philip's Church records, which date from 1867 to 1994 (bulk: 1957-1978), document the complex ways the church addressed the spiritual, social, intellectual, civic, and recreational needs of its parishioners and community members. Files include correspondence; meeting minutes; financial records; manuscripts; handwritten notes; church bulletins; blueprints; scrapbooks; photographs; and sound recordings.

The collection is divided into two series: Series I: Church Files and Series II: Pastor Weston's Files. The

earliest documents in the collection pertain to confirmations, the vestry, church finances, bequests, and property and date from the 1860s to the 1930s; however, the majority of the records reflect the church's activities from the 1950s through the 1970s. The influence of Pastor M. Moran Weston who served as rector from 1957 to 1982, is evident in the bulk of the collection. The collection also reflects Weston's board involvement with a number of organizations, and his domestic policy concerns from the 1950s through the 1970s. His theological and social beliefs are reflected in his speeches, sermons, and writings, while his board commitments are represented in files of organizational correspondence and meeting minutes. Weston's rectorship is also documented through his correspondence and subject files.

While the remainder of the collection also addresses Weston's role as pastor and leader, the church files document broader aspects of the church, specifically its involvement in real estate and housing; its role providing social services and commitment to challenging injustice; the everyday activities of the church as a place of worship; and administrative matters including the church's finances and personnel. The church files consist of property records and proposals for property developments, financial and program reports, correspondence, and administrative files for the St. Philip's Community Service Council. Vestry minutes, registers, and baptism and confirmation records document the high level administration of the church, its attendance, and the Christian rites of baptism and confirmation.

Series I: Church Files 1867-1980s (73 boxes, 8 volumes, 4 oversize folders)

The Church Files pertain to the administrative operations of the church and its affiliated entities, particularly its housing properties, the Community Service Council, and other initiatives to improve the neighborhood, housing, and services for senior citizens and youth. In some cases these files overlap with Weston's files. The Church Files are divided into four subseries.

Subseries I. A. Administrative 1867-1980s

The Administrative subseries documents the church's overarching concerns and management. These records provide insight into the church's fiscal health, vestry and membership matters, personnel practices, and special events. Events, anniversaries, and reunions are documented through press releases, flyers, programs, and ephemera. Registers of church services from 1924 to 1979 served as a daily record of attendance at church. Wills, deeds, and mortgages dating to the early 1900s reveal the physical and monetary assets owned by and bequeathed to the church.

Limited information regarding baptisms and confirmations performed by the church is available in the collection, including a small amount of confirmation applications and incomplete lists. Information on confirmations performed in the 1870s-1880s, 1957-1969, and 1973 is available; baptisms in 1949-1950, 1953, and 1957 are also represented.

Financial

The Financial records primarily cover the late 1950s through the 1970s. However, a limited number of financial reports are present for the years 1925, 1927, and 1930-1931. In addition to financial reports, the church's 1960s Building Fund Campaign is documented. There are also several sheets used to record the money received by the church during Sunday services and a few documents pertaining to the church's finance committee.

Subseries I. B. St. Philip's Church Housing Corporation 1962-1979

The St. Philip's Housing Corporation files detail the church's real estate interests and ownership of over 600 apartments near the church. The church had purchased apartments on 135th Street in 1911, foreshadowing the migration of many African Americans from elsewhere in New York City and from the Southern United States to Harlem. By the end of the 1970s, St. Philip's operated the St. Philip's Senior House, St. Philip's on the Park, and apartments on West 135th Street.

Pastor Moran Weston acted as president of the St. Philip's Housing Corporation; Dallas Selsey, the director of the St. Philip's Community Council and the church's development officer, served as vice president and secretary. The church's rental properties provided both the financial means to carry out the church's functions and programs and a practical way to directly improve the lives of Harlem residents. Professional management companies oversaw the properties' day-to-day operations under the direction of several boards of directors. African American architects Henri A. LeGendre and Percy Ifill were employed for the rehabilitation of the rental properties and church's community center. Because the church sought to hire African American businesses, there are several lists of minority contractors in these files.

The records chronicle administrative and financial matters, construction and rehabilitation projects, and the church's cooperation with federal, state, and city agencies to finance and administer the housing, specifically the United States Department of Housing and Urban Development (through which St. Philip's submitted a Section 202/8 Proposal) and the Federal Housing Administration; the New York City Department of Buildings and Human Resources Administration; and the New York State Division of Housing and Community Renewal.

Blueprints and correspondence with contractors and architects show site specifications and building plans; correspondence with elected officials, city agencies, and architects explain proposals for the properties; financial reports reveal the real estate's effect on church finances. Files for the boards of directors contain meeting agendas, minutes and related correspondence.

Researchers interested in the Senior House should also consult the St. Philip's on the Park files. St. Philip's on the Park

The most well-documented property is St. Philip's on the Park (480 St. Nicholas Avenue). Completed in 1975, the building was developed as part of the St. Nicholas Park Urban Renewal Area in partnership with the Department of Housing and Urban Development (HUD). Early files relate to the construction and renovation and the HUD application to develop the property. Correspondence with the Jackie Robinson Management Corporation reveals the day-to-day management issues and conditions within the building. Several files pertain to the church's relations with the St. Nicholas Park Community Council and the property's tenant association.

W. 135th Street

The 107-145 West 135th Street apartments were the church's first rental properties and consisted of ten six-story buildings containing nearly 200 apartments and commercial tenants. These buildings underwent extensive rehabilitation in the 1970s. The financial files for these properties contain information about parishioners' loans. Several third-party plans to manage the properties are available in the files.

Subseries I. C. St. Philip's Community Service Council 1951-1979

The St. Philip's Community Service Council (CSC), which was incorporated in 1951, provided childcare and social, cultural, and recreational opportunities to youth, senior citizens, and community members who were both affiliated and unaffiliated with the church. Many of the non-sectarian programs targeted the human, social, intellectual, moral, and civic development of hundreds of children in Harlem. Overall, the CSC files demonstrate the expansion of St. Philip's services to the local community, particularly under Weston's leadership and the results of a multi-year building and expansion campaign.

The church operated a community center at 207 West 133rd Street and opened the Upper Manhattan Day Care and Child Development Center in 1970. The programmatic, operational, and administrative work to run these facilities is well-documented. Pastor Weston served as president of the CSC and Dallas Selsey directed the CSC and its community center. In the early 1970s, Edward R. Culvert was the director of the Upper Manhattan Day Care and Child Development Center and the community center's evening program. Other leaders included Sidney Alexander and Albert Edwards; the latter directed the community center from 1959 to 1970.

The earliest years of the Community Service Council are primarily documented in the board of directors files and the monthly program reports. The CSC financial files speak to the council's fundraising and grant application efforts and the organization's overall fiscal health. Topical files reveal the types of programming provided by the CSC including afterschool, evening, and summer programs and elucidate the partnerships with other community organizations including the Day Care Council of New York, the City University of New York (CUNY), and a variety of Harlem-based groups.

Series II: Pastor Weston's Files 1881-1994 (147 boxes)

Pastor Weston's Files document his 25 years of service as rector of St. Philip's Church. His ministerial, entrepreneurial, and community organizing work is well-represented, while personal records and mementos are scant. In some cases, Pastor Weston's files complement or overlap with Series I. Pastor Weston's files are divided into four subseries.

Subseries II. A. Organizations 1958-1979

Pastor Moran Weston served on the boards of several non-profit agencies and academic institutions not affiliated with St. Philip's Church or with Carver Federal Savings Bank (a bank serving African Americans that Weston helped found). This subseries documents his service in the 1960s and 1970s to eight non-profit organizations and academic institutions. The Columbia University files occupy the largest segment in this subseries. Organization files are arranged alphabetically. Files relating to internal church agencies, to Carver Federal Savings Bank, and to other organizations Weston was less deeply involved with, can be found in the Correspondence and Subject Files subseries.

City University of New York

Files relating to the City University of New York (CUNY) document Pastor Weston's membership on the Citizens' Commission on the Future of the City University of New York and his utilization of CUNY's work study program. Commission files date from 1970 to 1972 and work study files date from 1973 to 1977. They include reports issued by the commission, memoranda about commission activities, and documents pertaining to CUNY's work study program.

Columbia University

Pastor Weston became the first African American member of Columbia University's board of trustees in 1969. He kept files reflecting routine board service matters as well as his concerns as a community leader in Harlem and his role as an alumnus of the university. Weston saw value in fostering cooperation among the church community, the Harlem neighborhood, and the Columbia campus. He used his position as a board member to advocate for affirmative action in student admissions, the hiring of more minority staff, and the greater involvement of minority-owned contractors on campus construction projects. He encouraged the university to bank with Carver Federal Savings Bank and acted as an advisor regarding the university's community real estate investments. These files document Weston's activity on numerous committees within the university board of trustees throughout the 1970s, including the Committee on Community Affairs; the Executive Committee; the Nominating Committee; the Committee on Educational Policy and the State of the University; the Research Administration Committee; and the Honors Committee. Trustees' agendas, schedules, meeting minutes, and notes are included. The files also reflect Weston's interest in Columbia University Press and Pulitzer Prize nominations.

St. Augustine's College

Pastor Weston served as chairman of the board of trustees at St. Augustine's College in Raleigh, North Carolina, where, in 1928, he was valedictorian of his junior college class. The St. Augustine's files date from 1969 to 1977 and document numerous aspects of Weston's service on the college board. Weston served on the nominating and executive committees, and was deeply involved in endowment funds, grants, and other financial concerns of the college. He occasionally gave commencement addresses at St. Augustine's, for which notes and transcripts are included. Weston was particularly interested in capital investments at the college, including construction of a new library building. Files on board meetings, board correspondence, reports from the college president, by-laws, and charters are also included.

Pastor Weston was a tenured professor of social history in the department of African and African American Studies at the State University of New York (SUNY), Albany from 1968-1977. These few SUNY files do not reflect his teaching, but instead primarily document his involvement in the Chancellor's Panel on University Purposes, which focused upon making higher education accessible to a wider range of students. Weston's initiation of a scholarship fund is also documented.

The Sermons, Speeches, and Writings subseries represents the intellectual output of Pastor Moran Weston. The subseries dates from 1935 to 1980 (bulk: 1957-1976). Civil rights, education, justice, urban issues, family concerns, and Biblical scripture are frequent themes. Included are manuscripts, typescripts, handwritten notes, outlines, and background research materials such as news clippings, journal articles, and white papers. It is arranged in three sections.

Sermons

Sermons comprise the greatest share of this subseries. They are arranged according to holidays and events of the liturgical calendar. Materials relating to a given holiday or event are filed together, starting with those occurring in January and running through those that occur in December. "Order of service" bulletins, which document regular Sunday worship services and often include short statements written by Weston, are plentiful throughout this section. Files rarely hold complete runs of sermons from every year. The early 1970s is the most well-represented period. Files frequently include sermon manuscript drafts and typescripts; Weston's handwritten notes exploring subjects to be addressed and bible verses to be cited in sermons; and outlines for sermons. Sermon themes are specific to the spiritual meaning associated with each holiday. Weston drew inspiration for his sermons from many sources, including poetry. A file of Christmas sermons from 1969 to 1979, for example, includes poems by Langston Hughes and Kenneth Patchen. News clippings and journal articles found in these files demonstrate Weston's intention to speak to the most relevant issues of the day, principally, national and local civil rights struggles. Newspaper clippings in these files indicate Weston's interest in the activities of the Black Panthers, and the campaign for and eventual passage of the Civil Rights Act of 1964. Some of the earliest materials in these files, from the 1930s and 1940s, which Weston may have referred to in the process of writing his own sermons, are from Weston's predecessor, Reverend Shelton Hale Bishop. A few sound recordings of sermons delivered by Weston in the early 1970s are present. Notes, manuscripts, and transcripts of sermons delivered by guest preachers appear from time to time in these files. Samples of pamphlets and Advent and Lent donation cards for parishioners are also present in these files.

Speeches

Pastor Weston frequently spoke in academic settings, at conferences, and at civic functions around New York City and the United States, addressing civil rights, justice, urban affairs, city planning, and education. The bulk of these speeches are from the early 1960s. A speech of particular note is the one Weston delivered at a special service at Washington Cathedral on the occasion of the passage of the Civil Rights Act of 1964, which can be found in box 123. Weston delivered another speech, titled "The New Missionary Frontier: The American Metropolis," at the San Francisco Conference on Metropolitan Planning in 1963. Files contain, in varying proportions: speech scripts; outlines; notes for unscripted speeches; research material; and travel records for out-of-town speeches. The occasional presence of cut and notated "order of service" bulletins and sermon manuscripts in these files indicates that Weston sometimes adapted themes, ideas, and passages from his sermons into his secular speeches. Besides traditional addresses, these files also include benedictions, invocations, short prayers delivered away from St. Philip's Church, and other brief remarks. Speeches are arranged chronologically, with speech locations and/or titles listed wherever specified.

Subseries II. C. Correspondence 1949-1979

The correspondence files provide evidence of Weston's energetic presence within the Harlem community and the depth of his connections throughout New York City and beyond.

Relationships Weston maintained with his clergy colleagues are well documented in these files. Among these, correspondence with Bishop Paul Moore and Bishop Horace Donegan, stand out. Weston was frequently in touch with New York politicians and city officials, including Mayor Abe Beame; Mayor John Lindsay; Governor Nelson Rockefeller; Congressman Charles Rangel; Senator James Buckley; David Dinkins, prior to his term as mayor; and Hubert Humphrey. In correspondence with political figures, Weston often prevailed upon them for services for the community, to request that they appear at church fundraising events, or sometimes to offer his support to their election campaigns. Letters to and from prominent African American intellectuals, civil rights activists, and other luminaries such as: Percy Sutton; Thurgood Marshall; Jackie Robinson; and Ruby Dee and Ossie Davis are also included. One such letter from Langston Hughes reveals that Weston attempted to interest the author in writing a history of St. Philip's Church. Another letter from Alex Haley invites the pastor and Mrs. Weston to visit Haley in the West Indies. Most correspondence with outside clergy, political figures, authors and celebrities can be found in the Names section of this subseries.

A significant portion of the correspondence is with St. Philip's parishioners. Weston kept correspondence files on new members of the parish, files of condolence letters sent to family members when parishioners died, and files of letters of thanks sent to and from parishioners. Correspondence predominantly consists of formal business correspondence, but some personal letters and cards are also sporadically included. Most parishioner correspondence can be found in the Subjects section of this subseries. Dallas R. Selsey, a lawyer who served as Development Officer of the church and who functioned for a time as Weston's primary associate, is Weston's most frequent correspondent. Selsey files fill three boxes dating from 1970 to 1978 in the Names section of this subseries. Numerous notes and memoranda between Weston and "DRS," as Selsey often signed his letters and notes, also appear throughout the entire collection. Letters to church staff reveal Weston's hands-on involvement in managing church personnel, handling day-to-day church affairs, and overseeing facilities. Some drafts of letters in shorthand, address lists, and rolodex cards are also included in this section. Most correspondence on such church matters can be found in the dated section and the Subjects section of this subseries.

Subseries II. D. Subject Files 1881-1994

The Subject Files demonstrate Weston's wide-ranging concerns. Some subjects relate strictly to the church, while others deal with Weston's entrepreneurial, academic, or civic interests. Important church subjects include annual luncheon files, composed of event programs, planning materials, and related correspondence for this annual fundraising gala for the church, spanning 1968 to 1980. Files on the 150th anniversary of St. Philip's Church document planning for and celebrations of the anniversary, which took place in 1968. Some routine church statistics can be found in the Subjects section. Pastor Weston kept a running daily tally of those to whom he and other pastors at St. Philip's ministered. These "day sheets" run continuously from 1963 to 1970 and from 1975 to 1977. Weston also kept "Sunday reports," which noted collection plate totals and what the weather was like each Sunday. A cache of sick call request forms record Weston's and other pastors' visits to ill and elderly parishioners in their homes and in hospitals. Weston kept his own set of Vestry files, which document meetings and operations of church officials in the 1960s and 1970s. Other pastoral administration files found in this section include a scattering of baptism, burial/funeral, marriage, and parish transfer records from 1957 through the 1970s. Files on the Episcopal Diocese of New York and the Episcopal convention connect St. Philip's and Pastor Weston to the larger church community around the New York City region, the United States, and internationally. Fundraising files track efforts to bring in money and ideas for fundraising campaigns, relating to the church in general and to specific services and programs offered through the church.

There is some overlap among Weston's subject files relating to the church and the Church files series. In some groupings of records, gaps in one series are filled or complemented in the other. Weston kept his own files on the St. Philip's Community Service Council (CSC). These files reflect Weston's role as president of the CSC and differ from the Church Series CSC files, chiefly in their inclusion of Weston's notes and interactions with other CSC board members. Numerous files on the Community Service Council document the work of the council, primarily consisting of meeting minutes and reference material from New York City agencies, non-profit groups, and private corporations concerning children's and youth services, senior care, and real estate. There are also numerous files on the day care program, housing, and senior housing filed separately in this section. Several files on Carver Federal Savings Bank, a bank created to serve African American customers, which Weston helped to found, document his service on its board of directors from 1961 to 1978.

Several files of photographs contain portraits of Weston over the years, portraits of visiting preachers, candid snapshots, and professionally photographed events. Examples of event photographs include a groundbreaking ceremony for the Community Youth and Cultural Center in Central Harlem and an annual luncheon attended by recently elected New York Congressman Charles Rangel. Three scrapbooks are included in this section, the first is filled with clippings dating from the early years of the church in the 1880s; the others are from 1958 and approximately 1962. An incomplete file of St. Philip's Church newsletters dating from 1960 to 1985 is present, as is a small selection of newsletters published by other organizations. Newsletters can also be found in the Church Files series.

Under the auspices of his professorship at SUNY Albany, Weston began a scholarly study of black family histories that is documented here with project outlines, grant applications, interview transcripts, correspondence, family trees, and other materials. Weston gathered family history information on over two dozen people for this project, which appears to have been ongoing for a period of time in the 1970s, though never completed. Weston also attempted to marshal resources to publish a black encyclopedia during this same period. Files on this subject include correspondence in which Weston pitched the idea to publishers and research material.
