## Creator History

Theology in the Americas (TIA) was formed in 1974 to begin the process of exploring the meaning of liberation theology for North America. It was initiated by Father Sergio Torres and others who brought together a multiracial coalition of approximately sixty action/reflection groups, comprised of both Catholics and Protestants, who were seeking qualitative social change in the United States and a new way of doing theology based on the grassroots experiences of people who are oppressed by racism,

sexism, classism, and imperialism. The first set of conversations culminated in a conference in August 1975 in Detroit, sponsored by the Latin American Secretariat of the United States Catholic Conferences and the Latin American Working Group of the National Council of Churches. Two hundred North American and Latin American theologians met to explore the possibilities of utilizing the Latin American "theology of liberation" for its possible relevance to North America.

According to TIA's brochure, the 1975 conference, known as Detroit I, brought together social activists, theologians, and community and church leaders, who shared their experiences of oppression as Blacks, Hispanics and Hispanic-Americans, Pacific/Asian Americans, women, workers, or marginalized whites. The conference focused on the socioeconomic exploitation of minorities, human rights violations, and class struggle, and attempted to determine what role theology and the church might play to alleviate these injustices. The Detroit I Conference established a network of projects or affinity groups including the Black Theology Project, the Hispanic Project, the Women's Project, Quest for Liberation in the White Church, the Task Force of Professional Theologians, Labor and Church Dialogue, Asian Americans in the North American context, and Native Americans and Red Theology. From 1975 until the Detroit II Conference in August 1980, each project developed its own agenda out of its felt oppression, held its own conferences, made its own statements in line with the overall TIA direction, and at times, made some effort to establish inter-project dialogue. The Detroit II Conference either included or gave rise to the following projects: Asian American/Pacific Theology, Black Theology Project, Church and Labor Project, Hispanic Theology Project, Native American Project, Theologians Task Force, Women's Project, and the Alternative Theology Project, later called the White Affinity Group. The conference was attended by over 550 individuals and saw the emergence of the Inter-Ethnic-Indigenous Peoples' Caucus which represented a significant advance in inter-project dialogue between the Black, Hispanic, Asian, and Native American participants. The Labor and Church Projects also affirmed an inter-ethnic, multi-racial approach for supporting labor struggles in the 1980s. The Women's Project not only advanced the feminist perspective, but also inter-project work with women of the various projects.

In the 1980s the leadership of the Theology in the Americas Project was transferred to Chicago's Trinity United Church of Christ under Reverend Jeremiah Wright; since 2003, the Samuel DeWitt Proctor Conference has held annual conferences which focus on training ministers to become progressive and socially conscious activists.

Conferences 1974-1982

The Conferences series consists of records which pertain to the Detroit I Conference held in 1975. These records include planning documents, invitation lists, publicity and press reports, personal data sheets filled out by the participants, files concerning the reflection groups, and transcripts of talks by many of the participants. The Detroit II files provide a history of the projects, applications from the participants of the various affinity groups as well as international guests, press articles, and an interview with black theologian James Cone who was a proponent of Black Theology. There are also transcripts of the papers presented at the conference and a manuscript of these same papers that were published in book form (*Theology in the Americas*, 1976).

Black Theology Project 1976-1985

The Black Theology Project files contain information about one of the conferences it sponsored, "Black Church and Black Community: Unity and Action for Education" (Atlanta, August 1977); a draft of a paper by Jualynne Dodson about the Fourth Inter-ethnic/Indigenous Dialogue (1984); and minutes of Executive Committee meetings and the board of directors, chaired by Howard Dodson. While Theology in the Americas did not survive beyond the late 1980s, the Black Theology Project had the strongest infrastructure, and in about 2003, the organization Samuel DeWitt Proctor Pastor Conference was formed to advance social justice, holding annual conferences.

The Hispanic Theology Project concerns problems of immigration, migrant workers, bilingual education, and related in the economic, social, political and cultural issues; files pertain to several conferences and organizations, among them the Joint Strategy and Action Committee-Hispanic American Ministries (JSAC/HAM), a Hispanic Ecumenical gathering held in San Antonio, Texas in 1978, the Detroit II Conference in 1980, and Padres Asociados para Derechos Religiosos Educativos y Sociales (PADRES). Planning documents, conference evaluations, minutes of meetings, papers re liberation theology, and files discussing cooperation with Protestant organizations are also to be found in the Hispanic Theology Project Records. Approximately 20% of the Hispanic Project files are written in Spanish.
